## DRPH CURRICULUM


### BACKGROUND

CEPH reviewed DrPH curricular requirements for all 37 units that offered a DrPH degree as of December 2019.\* Two of the units offered required curricula that differed structurally among concentrations, so this report considers each of these separately, for a total of 40 DrPH programs of study.


#### CURRICULUM

Though all DrPH curricula address the foundational competencies defined in the 2016 Criteria, DrPH curricula vary widely. One commonality occurs in required coursework: two major clusters of course types typically constitute more than half of the foundational didactic curriculum required of all DrPH students.



### STRUCTURE & DISTRIBUTION OF CREDITS

Existing DrPH curricula are divided almost evenly between units that offer a single DrPH ("single concentration curricula") and units that offer multiple concentrations ("multi-concentration curricula"). Most single concentration curricula are structured around advanced practice and leadership skills.


The two types of curricula share the same median for overall credit requirements and distribution of credits between didactic coursework and other experiences. They differ in the structure and distribution of didactic coursework, as illustrated below.



Because of this difference in the distribution of didactic coursework, single-concentration curricula have more courses that are required of all DrPH students. Required courses are not all equal in credits and ranged from 0 semester-credits to 4.5 semester-credits.

## CLASSES REQUIRED OF ALL STUDENTS

The table below presents the prevalence of courses by topic area across all 40 DrPH programs of study. Foundational curricula include a median of two BRE courses (shaded pink, below) and two LAMPE courses (shaded blue, below). These two courses may be in the same topic area (e.g., two research methods classes) or may be drawn from different topic areas in the same domain (e.g., one research methods class and one biostatistics class).
